By submitting this subscription order, the subscriber agrees to the following terms and conditions.

1. All subscriptions are subject to acceptance by CANNEX. Upon acceptance, CANNEX shall issue to the Subscriber a User ID and password which will be sent to the Subscriber by fax or e-mail.
2. CANNEX shall make available to the Subscriber, by way of access to www.cannex.com, access to the CANNEX database of financial information (the CANNEX Service). CANNEX grants to the Subscriber a non-exclusive, non-assignable, and non-transferable license to access and use the CANNEX Service, solely for the use of the Subscriber and the Subscriber's clients.
3. The Subscriber agrees not to publish or distribute, or to permit anyone else to publish or distribute, the information obtained from the CANNEX Service. Subscriber may provide individual copies of information, surveys or reports to clients in the course of providing other financial services to such clients, but shall not make any separate charge for providing such information.
4. The Subscriber shall reference CANNEX as the source of the information, survey or report on all copies made by Subscriber. Any other use by the Subscriber of the trademark "CANNEX" or any other trademark or trade name of CANNEX shall require the prior written approval of CANNEX.

Additional Terms Applicable to Daily Stock Prices, with CUSIP, data file service
